How to Use Dial-in Conference Line (details below)

We are looking for Girls State Alumna, ALA volunteers, or any CA residents to call into the committee teleconference and simply state their opposition.

Here are some options for opposition statements:

1. "Hello, my name is _____, I am an ALA California Girls State Alumna (*Year*) and I although I support the spirit of this bill, I **oppose** this bill as currently written."
2. "Hello, my name is _____, from _____, California and I **oppose** this bill as amended."
3. "Hello, my name is _____ American Legion member/ American Legion Auxiliary member and I **oppose** this bill as written, with specific reference to the timing concerns.
 - SB 363 is **second** up on the agenda. At the end of SB 363 committee discussion, they open it up for public comment.
 - The Judiciary Committee meeting starts @ 1:30pm.

- Upon calling in, you will be placed in a “waiting room” where you will be muted but you can listen to the committee hearing as you wait. It is very important to note, when you are calling in, you must mute the device you are watching the committee hearing on. **There is approximately a 40 second lag time between the phone and video.** In order for you to stay in “real time” and to know when you are being prompted to give testimony, you must listen through your phone and NOT follow the live video.
- When a committee moves to **public comment**, a moderator will ask for anyone wishing to testify in “Support” of the bill to please press 1-0. The moderator will again prompt those waiting in “**Opposition**” when the committee moves to opposition. You should press 1-0 when you are prompted by the moderator – be sure to listen for support or opposition, and DO NOT press 1-0 until the proper position has been asked for.
- When you press 1-0 on your phone, you will wait and an operator will assign you a line number, at that time you will be placed in the queue for identification. **Remember your line number, the moderator will call out that number to identify YOU when it is your turn to testify.**
- When you are successfully placed in the queue, with your assigned line number, the moderator will call out your line number, open your line, and at that time you may address the committee.
